**Sub: Intimation about resumption of operations at Halol plant in phased manner under Regulation 30 of Securities Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.**

This is in continuation of our earlier intimation given vide letter dated March 27, 2020 about temporary closure and suspension of manufacturing operations of all plants of the Company in light of the outbreak of COVID-19 pandemic until further notice.

In view of the various directives / guidelines issued by the Central Government and State Government (Gujarat) on the exemptions from lockdown, and by adhering to the Standard Operating Procedures/ Guidelines for Industrial Units, prescribed by the Gujarat State Government, the operations of our plant located at Village-Khakharia Taluka: Savali, Halol have resumed in phased manner with effect from April 27, 2020. The resumption inter-alia includes activities like plant preparedness, following all safety & hygiene norms directed by Central / State Government, inspection, trial production etc. The plant has followed and complied with necessary requirements of the State Government in this regard.

The Company will continue to assess the situation and intimate the updates on other plant(s), once they resume operations.
