**Sub: Intimation about resumption of operations at Chakan plants in phased manner under Regulation 30 of Securities Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.**

This is in continuation of our earlier intimation given vide letter dated March 27, 2020 about temporary closure and suspension of manufacturing operations of all plants of the Company in light of the outbreak of COVID-19 pandemic until further notice.

In view of the various directives / guidelines issued by the Central Government and State Government (Maharashtra) on the exemptions from lockdown, and by adhering to the Standard Operating Procedures/ Guidelines for Industrial Units, prescribed by the State Government, the operations of our plants located at Gat No. 427, Medankarwadi, Chakan and at Survey No. 679/2/2, Alandi Road, Kuruli, Chakan, Taluka: Khed, District: Pune have resumed in phased manner based on customer demand with effect from May 7, 2020. The resumption inter-alia includes activities like plant preparedness, following all social distancing, safety & hygiene norms directed by Central / State Government at workplace to ensure safety and wellbeing of all workers and employees, inspection, trial production etc. The plants has received necessary permissions and complied with requirements of the State Government in this regard.

It is too early to envisage the financial impact of this temporary disruption of manufacturing operations at all Plants of the Company. Its impact will be ascertained in due course based on the culmination of this pandemic outbreak of COVID-19.
